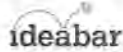

A. CALL TO ORDER

Mr. Ellington called to order the February 13, 2017, Regular Board Meeting of the Thousand Oaks Community Development District at 5:00 p.m. at the Administrative Office of Thousand Oaks at Congress Master Association, Inc. located at 1034 Center Stone Lane, Riviera Beach, Florida 33404.

B. PROOF OF PUBLICATION

Proof of publication was presented that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on February 1, 2017 as legally required.

C. ESTABLISH A QUORUM

A quorum was established by the presence of Chairman Jeff Jackson (by conference call), Vice Chairman Randy Hicks, and Supervisors Kimberly Jackson, Rance Gaede, and Corey Smith.

Staff present were: District Manager Richard Ellington of Special District Services, Inc. and District Counsel Frank Palen of Caldwell Pacetti Edwards Schoech & Viator LLP.

Also present were Claudio Silvaggi, Ron Jewell and Kena Brown of the HOA.

Mr. Ellington indicated at the beginning of the meeting that this was intended to be a joint meeting the CDD Board and the HOA Board for the Thousand Oaks community. However, no Board Members from the HOA were present.

Since this was a regularly scheduled meeting, Mr. Ellington went through the agenda.

There were no additions or deletions to the agenda.

H. NEW BUSINESS

1. Discussion Regarding Preserve Area Maintenance

Mr. Ellington indicated that since the meeting was intended to be held jointly with the HOA Board, that there really was not a whole lot of the business for the Board to do. Ms. Brown indicated that the HOA Board had been made aware of the action taken by the CDD Board at its prior meeting to allocate an amount not to exceed \$20,000 to do maintenance on the preserve area and then follow the first recommendation under the Higgins Report of not doing anything for 3 years and then coming back and taking cross sections of the preserve slope. The Board indicated they were continuing to agree with that position and authorizes staff to start the work to hire a contractor to do the maintenance that would be required. Mr. Ellington indicated that a set of specifications would need to be developed and that the District would have to work with South Florida Water Management District, particularly Mr. Todd Warren, to make sure they do not violate any of the conditions of the original permit or the modified permit.

There were no Administrative Matters to come before the Board.

There were no comments from the Members of the Board.
