

THOUSAND OAKS COMMUNITY DEVELOPMENT DISTRICT PUBLIC HEARING & REGULAR BOARD MEETING AUGUST 8, 2022

A. CALL TO ORDER

The August 8, 2022, Regular Board Meeting of the Thousand Oaks Community Development District (the "District") was called to order at 4:15 p.m. in the Thousand Oaks HOA Office located at 1034 Center Stone Lane, Riviera Beach, Florida 33404.

B. PROOF OF PUBLICATION

Proof of publication was presented that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on October 6, 2021, as part of the District's Fiscal Year 2021/2022 Regular Board Meeting, as legally required.

C. ESTABLISH A QUORUM

A quorum was established by the presence of Chairman Jeffrey Jackson (via phone), Vice Chairman Rance Gaede and Supervisors Malachi Knowles and Horace Towns.

Staff present included District Manager Sylvia Bethel of Special District Services, Inc.; and General Counsel Frank Palen of Caldwell Pacetti Edwards Schoech & Viator LLP.

D. ADDITIONS OR DELETIONS TO THE AGENDA

There were no additions or deletions to the agenda.

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES

1. July 11, 2022, Regular Board Meeting

A **motion** was made by Mr. Knowles, seconded by Mr. Towns and passed unanimously approving the July 11, 2022, Regular Board Meeting minutes, as presented.

The Regular Board Meeting was then recessed and the Public Hearing was opened.

G. PUBLIC HEARING 1. Proof of Publication

Proof of publication was presented that notice of the Public Hearing had been published in *The Palm Beach Post* on July 19, 2022, and July 26, 2022, as legally required.

2. Receive Public Comment on Fiscal Year 2022/2023 Final Budget

Page 1 of 5

There was no public comment on the Fiscal Year 2022/2023 Final Budget.

3. Consider Resolution No. 2022-02 – Adopting a Fiscal Year 2022/2023 Final Budget

Resolution No. 2022-02 was presented, entitled:

RESOLUTION NO. 2022-02

A RESOLUTION OF THE THOUSAND OAKS COMMUNITY DEVELOPMENT DISTRICT ADOPTING A FISCAL YEAR 2022/2023 BUDGET.

Mr. Jackson inquired about having funds to cover extra expenses. Mr. Gaede responded by stating that funds were set aside under Preserve Erosion Repair and Contingency.

A **motion** was then made by Mr. Knowles, seconded by Mr. Towns, and unanimously passed adopting Resolution No. 2022-02 – Adopting a Fiscal Year 2022/2023 Final Budget, as presented.

The Public Hearing was then closed and the Regular Board Meeting was reconvened.

H. OLD BUSINESS

1. Update on Logos for Shirts

Mr. Knowles indicated that he had "dropped the ball," but would have information for the next meeting.

2. Update on Preserve Site Visit Report

Ms. Bethel advised that Mr. Grimm followed-up that he had visited the community and found several violations. He indicated he would email Ms. Bethel a copy of said violations. Ms. Bethel advised that she had followed up with Mr. Grimm, but has not received a response. She noted she would once again follow-up with his supervisor.

3. Consider Trimming and Tree Removal Proposals for Dry Conservation Area and Along Congress

Ms. Bethel advised that this item had been approved at the last meeting and Mr. Russ coordinated with the HOA/Mr. Jackson to begin the project.

4. Discussion Regarding Encroachment Letter to Resident from Attorney

Ms. Bethel advised that she was awaiting a response from Mr. Grimm of the City of Riviera Beach.

5. Discussion Regarding Engineer's Report

Ms. Bethel indicated she had been e-mailing Mr. Schnars, but had not yet received a response. She will continue to follow-up with him.

6. Discussion Regarding Stormwater & Wastewater 20-Year Needs Analysis

Page 2 of 5

Ms. Bethel indicated that this item was discussed at the last meeting and should be removed from the agenda.

7. Discussion Regarding Funds Owed to HOA Regarding Fence Line Tree Trimming

Ms. Bethel stated that Mr. Jackson was supposed to update the Board with an amount for reimbursement. Mr. Jackson said he would do so.

8. Discussion Regarding ATV Purchase versus Rental

Ms. Bethel indicated that Mr. Gaede had sent over a picture of an ATV, which was sent to a vendor who returned a proposal. Mr. Jackson visited an ATV business as well and Ms. Bethel followed up and received two more proposals. A lengthy discussion ensued. Mr. Palen inquired if the HOA had fire insurance to cover an ATV. If not, that is something they may want to look into. Mr. Towns indicated that we may be able to piggy back off of the Sherriff's office. Mr. Knowles noted that he would like to table this item until the next meeting so further details can be worked out, i.e., an agreement from the HOA about storage.

9. Discussion Regarding Newsletter and Website

Ms. Bethel advised that she had sent an e-mail to the Board about biographies, but had not received any responses. The Board indicated they would send them to her.

10. Discussion Regarding District Bond Debt and Projected Payoff Date

Ms. Bethel advised that this was discussed at the last meeting would be removed from the agenda.

I. NEW BUSINESS

1. Consider Resolution No. 2022-03 – Adopting a Fiscal Year 2022/2023 Meeting Schedule

Resolution No. 2022-03 was presented, entitled:

RESOLUTION NO. 2022-03

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE THOUSAND OAKS COMMUNITY DEVELOPMENT DISTRICT, ESTABLISHING A REGULAR MEETING SCHEDULE FOR FISCAL YEAR 2022/2023 AND SETTING THE TIME AND LOCATION OF SAID DISTRICT MEETINGS; AND PROVIDING AN EFFECTIVE DATE.

A **motion** was made by Mr. Knowles, seconded by Mr. Towns and passed unanimously adopting Resolution No. 2022-03, as presented.

2. Discussion Regarding Midge and Mosquito Treatment Proposal

Ms. Bethel indicated she had been contacted by the HOA about spraying for mosquitos. A lengthy discussion ensued. Mr. Knowles suggested two other locations that should be sprayed. Mr. Gaede stated it had to be CDD property. Mr. Towns inquired if this may be a County issue. Staff will follow-up on this issue.

3. Discussion Regarding District Investment Policy

Mr. Palen explained the investment policy. He furthered that surplus funds would have to first be identified. Funds being invested cannot be bond funds and cannot tax to invest. If the Board decides to adopt a policy, they will have seven options to invest. If you do not adopt a policy, then there are three options to invest. Mr. Knowles highly recommend that the Board invest the funds. Mr. Gaede would like management to identify surplus finds and look into an investment company.

4. Consider New Fountain Proposal

A lengthy discussion ensued about purchasing two fountains/placement locations/negotiations.

A **motion** was made by Mr. Knowles, seconded by Mr. Towns, to not approve the purchase of two fountains, given the scope of work in the Palm Beach Aquatics quote at a cost not to exceed \$22,000. Upon being put to a vote, Messrs. Gaede, Towns and Jackson dissented.

A **motion** was then made by Mr. Towns, seconded by Mr. Jackson and unanimously passed approving the purchase of two fountains, given the scope of work in the Palm Beach Aquatics quote at cost not to exceed \$24,000 to be further negotiated by Ms. Bethel.

J. ADMINISTRATIVE MATTERS

There were no Administrative Matters to come before the Board.

K. BOARD MEMBER COMMENTS

Mr. Knowles inquired about the signs. Mr. Jackson stated he received a call today about installation of the signs.

Ms. Bethel brought up a handout of the scope of work from Mr. Wells that was missed under Encroachment Letter to Resident from Attorney. Mr. Palen mentioned that Mr. Wells was not registered in Florida. Mr. Palen noted that Mr. Wells would need proof of insurance and a Palm Beach County Business Tax Receipt. Mr. Gaede indicated that it seemed like the scope of work pertains to the HOA and not the CDD. The Board directed staff to contact Mr. Wells about items needed in order to move forward with this project.

L. ADJOURNMENT

There being no further business to come before the Board, the meeting was adjourned at 5:24 p.m. on a motion made by Mr. Knowles, seconded by Mr. Towns and passed unanimously.





Good morning,

Unfortunately, 4 months ago they would have easily been able to get the 2 fountains with lights for the \$24,000 but due to the constantly increasing cost of products, it is difficult to get the price down to what they were at the start of this year. However, I did everything I could to help on the price. To get the price close to what they requested, I had to change the 4 x 36w lights to a 2 x 36w light set, in addition to some other minor adjustments.

The only other option to get them closer to the \$24,000 would be to decrease the size from a 5 hp to a 3 hp. I've included a quote for both options but please keep in mind, the smaller horsepower will have smaller pattern dimensions, however it will put them closer to the price they're looking for. Opinion they would be much happier with the larger fountain, but it is ultimately up to them.

 Please look at the graph at the bottom of the image below to compare the differences in the 3hp and the 5hp. Look for the column marked (HP) – Horsepower. Go down to the rows marked 3 and 5 and follow those rows a across comparing the differences between the columns marked (Ht.) - Hight / (Dia.) - Diameter / (GPM) - Gallons Per Minute. The 3hp and 5hp have an <u>8-foot difference in height</u>, a <u>11-foot difference in width</u> and only a <u>50 gallon per minute difference in water movement</u>.




