A. CALL TO ORDER

The November 3, 2025, Regular Board Meeting of the Thousand Oaks Community Development District (the "District") was called to order at 4:16 p.m. in the Thousand Oaks' HOA Office located at 1034 Center Stone Lane, Riviera Beach, Florida 33404.

B. PROOF OF PUBLICATION

Proof of publication was presented that notice of the Regular Board Meeting had been published in *The Palm Beach Post* on September 22, 2025, as part of the District's Fiscal Year 2025/2026 Regular Board Meeting, as legally required.

C. MOMENT OF SILENCE

D. ESTABLISH A QUORUM

A quorum was established by the presence of Chairman Rance Gaede, Vice Chairman Corey Smith and Supervisors Malachi Knowles and Horace Towns.

Staff present was District Manager Sylvia Bethel (S. Bethel) of Special District Services, Inc; District Counsel Frank Palen and Frances Bethel (F. Bethel via phone) of Caldwell Pacetti Edwards Schoech & Viator LLP.

E. ADDITIONS OR DELETIONS TO THE AGENDA

Mr. Gaede requested the addition of a Discussion Regarding the Conference Call-In Line under New Business.

A **motion** was made by Mr. Smith, seconded by Mr. Knowles and passed unanimously adding a Discussion Regarding the Conference Call-In Line under New Business.

F. APPROVAL OF MINUTES

1. October 6, 2025, Regular Board Meeting

A **motion** was made by Mr. Towns, seconded by Mr. Smith and unanimously passed approving the minutes of the October 6, 2025, Regular Board Meeting with the correction of resolutions of condolences.

The Board requested that this be added to the next agenda.

G. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

H. OLD BUSINESS

1. Update on Logo Trademark

Following further discussion, a **motion** was made by Mr. Knowles, seconded by Mr. Towns and unanimously passed approving the Russ Total Lawn Maintenance proposals for the Preserve in the amount of \$25,500 and the Conservation area in the amount of \$7,850.

Mr. Gaede asked Ms. S. Bethel if anyone had been calling in to which she stated there had not been except for this meeting, as the attorney was on the line. Mr. Gaede stated he believed they should discontinue the line after December, and the Board agreed.
